Sir,

With reference to your letter cited above,
I am directed to say that the Governor of Assam is pleased
to approve your proposal for allotment of land measuring an area
of 36B-OK-3L covered by dag No. 249 and 251 of village khara Pt. II
to the Dudhnoi College.

I am therefore to request you to make the rest of
the land as "Sarkari Reserve" for Public purposes instead of
making the land as khas. All encroachers may be evicted imme-
diately. However, homestead land @ (half) ~~max~~ a bigha may be
settled to the seven numbers of landless families as reported
by local Sub-deputy Collector on realisation of premium on normal
procedure.

The possession of lands allotted to the college may be
handed over as khas free from encroachment prior to dereservation
of the area. You are also requested to submit the formal dereser-
vation proposal to Govt. immediately in respect of the land
involved.


