- The adjusted Assistant Professor(s) will be entitled to get UGC's basic pay of Rs.8,000/- (Rupees. Eight/thousand) only from the date of approval of Director of Higher Education, Assam as per condition No.4 of Govt. letter No.AHE.92/2009/Pt.II/26, dated 30-10-2010.
- The Teachers who have not yet acquired full UGC norms will be required to qualify in NET/SLET within 2 (two) years as per provision of Clause 4(d) as laid down under O.M. No.B(2)97/2003/98, dated 17-07-2004, otherwise their services would be discontinued and till then they will be entitled to get basic pay as admissible only from the date of approval by the Director, Higher Education, Assam. The Director, Higher Education, Assam must ensure if that the teacher acquires the required qualification within the time limit fixed in the O.M. dated 17-07-2004.
